## PROIZVODNJA I PRODAJA DRVNIH SORTIMENATA U FBiH, JANUAR/SIJEČANJ 2015. PRODUCTION AND SALE OF FORESTRY ASSORTMENTS IN THE FB&H JANUARY 2015

Ukupna proizvodnja šumskih sortimenata u januaru 2015. godine u odnosu na januar 2014. godine manja je za 46000 m<sup>3</sup> ili 37,7%.

Proizvodnja sortimenata od četinarara/četinjača manja je za 20000 m<sup>3</sup> (33,9%) dok je proizvodnja sortimenata od lišćara/listača manja za 26000 m<sup>3</sup> (41,3%).

Ukupna prodaja šumskih sortimenata u januaru 2015. godine u odnosu na isti mjesec 2014. je manja za 30000 m<sup>3</sup> (29,4%).

Prodaja sortimenata od četinarara/četinjača manja je za 11000 m<sup>3</sup> (22,4%) dok je prodaja sortimenata od lišćara/listača manja za 19000 m<sup>3</sup> (35,8%).

The total production of forestry assortments in january 2015 fell by 46.000 m<sup>3</sup> (37,7%) in relation to 2014.

Production of assortments of conifers fell by 20.000 m<sup>3</sup> (33,9%), while the production of assortments of broadleaves fell by 26.000 m<sup>3</sup> (41,3%).

The total sale of forestry assortments in january 2015 fell by 30.000 m<sup>3</sup> (29,4%) in relation to same month 2014.

Sale of assortments of conifers fell by 11.000 m<sup>3</sup> (22,4%), while sale of assortments of broadleaves fell by 19.000 m<sup>3</sup> (35,8%).

## METODOLOŠKA OBJAŠNJENJA

### Izvor i metode prikupljanja podataka

Podaci o proizvodnji šumarstva u državnim šumama rezultat su Mjesečnog istraživanja šumarstva ŠUM- 22 koje provodi Federalni zavod za statistiku na temelju Zakona o statističkim istraživanjima u FBiH «Sl. novine Federacije BiH» br. 63/03.

Mjesečnim Izvještajem šumarstva obuhvaćene su sve pravne osobe razvrstane u Registru poslovnih subjekata u području A- Poljoprivreda, lov i šumarstvo, odjeljak 02-Šumarstvo, sječa drveta i usluge povezane sa njima, a koje se bave stalnom proizvodnjom šumskih sortimenata u državnim šumama.

Prikupljanje podataka o proizvodnji i prodaji u šumarstvu vrši se na osnovi Nomenklature proizvoda i usluga šumarstva – NPUŠ, koja je izrađena za potrebe statistike šumarstva na osnovi Liste karakterističnih proizvoda šumarstva, koju je Eurostat (Statistički ured Evropske unije) objavio kao integralni dio Priručnika za ekonomske račune poljoprivrede i šumarstva (Manual on the Economic Accounts of Agriculture and Forestry – EAF) u novembru/studenom 1997. godine.

### Definicije

**Trupci** (lišćara/listača i četinar/četinjača) su dijelovi debla koji su namjenjeni daljem prerađivanju piljenjem, ponekad rezanjem ili ljuštenjem jer imaju povoljna fizička i kemijska svojstva te su namjenjeni za industrijsku preradu.

**Jamsko drvo** (lišćara/listača i četinar/četinjača) namjenjeno je za razne tehničke svrhe jer ima vrlo povoljna fizička i kemijska svojstva. To je drvo koje se upotrebljava za izgradnju i održavanje jamskih rovova i okna, dakle za gradnju u zemlji i pod zemljom.

**Ostalo dugo drvo** (lišćara/listača i četinar/četinjača) obuhvaća sve vrste drveta pogodne za mehaničku preradu, stupove za elektro vodove i TT vodove te ostalo oblo drvo.

**Prostorno drvo** (lišćara/listača i četinar/četinjača) obuhvaća drvo za drvene ploče (pogodno za mehaničku preradu), a celulozno i taninsko drvo, zbog svog povoljnog kemijskog svojstva, pogodno je za kemijsku preradu. Taninsko drvo je sirovina iz koje se preradom dobivaju taninski ekstrakti.

**Ogrijevno drvo** (lišćara/listača i četinar/četinjača) je namjenjeno neposredno za ogrjev ili za proizvodnju drvenog uglja.

**Ostalo grubo obrađeno drvo** (lišćara/listača i četinar/četinjača) obuhvaća sitno tehničko drvo, pogodno za izradu drvenih motki i kolja, raznih letvi i stupova za ogradu, ručica za alat i sl.

## NOTES OF METHODOLOGY

### Source and methods of data collection

Data on production of forestry assortment in the publicly-owned forests are result of monthly reports on surveys of forests (ŠUM – 22) conducted by the Federal Office of Statistics on the basis of Act on Statistical Survey in FB&H (Službene novine FBiH, No 63/03).

All legal entities classified in the Register of Business Entities under section A – Agriculture, hunting and forestry Section 02 – Forestry, felling and related services activities, engaged in permanent production forest sortiments in the publicly-owned forests, are extended by Monthly Report of forestry.

Data collection on production and sales of forestry is practised on the basis of the Nomenclature of Forest Products and Services NPUŠ which is made for the purposes of forestry statistics on the basis the List of Characteristic Products of the Commercial Timber Production compiled by the Eurostat (the Statistical Office of the European Union), and published as an integral part of the Manual for Economic Accounts of Agriculture and Forestry in November 1997.

### Definitions

**Logs** (broad-leaved trees and conifers) are parts of timber intended for further processing by sawing, sometimes by cutting or peeling, because of its good physical and chemical characteristics, so it is useful to be industrially processed.

**Mining timber** (broad-leaved trees and conifers) having very good physical and chemical characteristics, is intended for various technical purposes. It is used for building and maintaining pits and shafts, therefore, for constructing under ground and on the surface.

**Other long timber** (broad-leaved trees and conifers) includes all kinds of wood suitable for mechanical processing, transmission-line and telephone-line pylons as well as other oval timber.

**Stack wood** (broad-leaved trees and conifers) includes wood for boards (suitable for mechanical processing), and wood-pulp and tannin wood are, because of its good chemical characteristics, suitable for chemical processing. Tannin wood is a material that, processed, gives tannin extracts.

**Fuel wood** (broad-leaved trees and conifers) is intended directly for fuel or production of wood coal.

**Other roughly processed wood** (broad-leaved trees and conifers) includes paltry technical wood suitable for processing of wood poles, different bars and fence piers, tool cager etc.
