BROJNO STANJE STOKE I STOČNA PROIZVODNJA U 2014 GODINI NUMBER OF LIVESTOCKS AND LIVESTOCK PRODUCTION IN 2014

Prema prikupljenim i obrađenim podacima brojnog stanja stoke i peradi u 2014. i njihovim poređenjem sa rezultatima za 2013. porast brojnog stanja se bilježi kod sljedećih kategorija stoke: ovaca za 1,6%, konja za 0,2%, koza za 8,1% i košnica pčela za 2,1%. U odnosu na prethodnu godinu, smanjenje brojnog stanja je zabilježeno kod: goveda za 0,9%, svinja za 1,1%, peradi za 2,2% i kunića za 31,7%


U okviru stočne proizvodnje, u odnosu na prethodnu godinu, uslijed povećanja muznosti po grlu, zabilježen je porast proizvodnje kravljeg mlijeka za 5,5%, ovcijeg mlijeka za 6,5%, te kozičnjeg mlijeka za 10,5%. Povećana je i proizvodnja masne i neprane vune za 6,8%. U poređenju sa prethodnom godinom bilježi se pad proizvodnje jaja za 1,1% i meda za 23,9%.

According to the collected and processed data of the number of livestock and poultry in 2014 and their comparison with the results for 2013, an increase was recorded in the number of following categories of livestock: sheep by 1.6%, horse by 0.2%, goats by 8.1%, and beehives by 2.1%. Compared to the previous year, a decrease was recorded in the number of: cattle by 0.9%, pigs by 1.1%, poultry by 2.2% and rabbits by 31.7%.

Within livestock production, compared to the previous year, due to an increase in milk per animal, there was an increase of cow's milk production by 5.5%, ewe's milk production by 6.5% and goat's milk production by 10.5%. Production of fatty and greasy wool was also increased by 6.8%. Compared to the previous year, decrease was recorded in production of eggs by 1.1% and production of honey by 23.9%.

METODOLOŠKA OBJAŠNJENJA

Podaci o broju stoke i peradi (stanje 31.12.) prikupljeni su odvojeno za pravne osobe, dijelove pravnih osoba i porodična poljo privredna gazdinstva.

Za pravne osobe i dijelove pravnih osoba izvještajima se prikupljaju podaci o broju i težini stoke i peradi, košnicama pčela, bilanci goveda, svinja, ovaca i peradi, proizvodnji mlijeka (kravlje, ovčije i kozje), vune, jaja i meda.

Za porodična poljoprivredna gazdinstva općinske službe za poljoprivredu vrše procjenu broja stoke (ukupan broj i broj stoke za priplod) i proizvodnji mlijeka (kravlje, ovčije i kozje), vune, jaja i meda.

Pravne osobe i dijelovi pravnih osoba koji su obuhvaćeni istraživanjem razvrstani su po KD BiH 2010 u područje A (Poljoprivreda, šumarstvo i ribolov razredi od 01.41. do 01.49. i razred 01.50). Izvještaje podnose i pravne osobe koje su razvrstane u drugoj djelatnosti, a bave se uzgojem stoke, peradi i pčela.

Ovi podaci se koriste za praćenje ukupnog broja stoke i peradi, stočne proizvodnje, obračun bruto domaće proizvodnje (BDP), kao i za izračunavanje indeksa fizičkog obima poljoprivredne proizvodnje i ekonomskih računa u poljoprivredi.

NOTES ON METHODOLOGY

Data on the number of livestock and poultry (December 31) are collected separately from legal entities and their part, especially for the family owned farms.

For legal entities and their parts, through reports, are collected data on number, weights of livestock and poultry, beehives, balance of livestock, production of milk (cow, sheep and goat), wool, eggs and honey.

For family owned parts estimation is made by municipal services for agriculture. Estimated are data on number of livestock (total number and breeding animals), production of milk (cow, sheep and goat), wool, eggs and honey.

Legal entities and parts of entities included in the survey were classified, according to the KD BiH 2010, in section A (Agriculture, forestry and fishing), class of 01.41 to 01.49 and class 01.50. Legal entities that are classified in other activities, and engaged in the production of livestock, poultry and bees, are also included in survey.

This data are used to monitor the total number of livestock and poultry, livestock production, calculation of gross domestic production (GDP), as well as, to calculate the index of the physical volume of agriculture production and economic accounts for agriculture.
