## INDEKSI CIJENA PROIZVODA ČA INDUSTRIJSKIH PROIZVODA, NOVEMBER/STUDENI 2016. GODINE

### PRODUCER PRICE INDICES, NOVEMBER 2016

#### Ukupan indeks cijena proizvoda ča industrijskih proizvoda

U novembru/studenom 2016. godine ukupan indeks cijena proizvoda ča industrijskih proizvoda je viši za 1.8% u odnosu na prethodni mjesec.

Posmatrano prema glavnim industrijskim grupacijama indeks cijena energije je viši za 8.3% i ne trajnih proizvoda za široku potrošnju za 0.3%. Pad indeksa cijena je registrovan/registriran u grupaciji intermedijarnih proizvoda osim energije za 0.7% i kapitalnih proizvoda za 0.5%.

U grupaciji trajnih proizvoda za široku potrošnju indeks cijena se nije mijenjao.

Posmatrano prema područjima KD-a, indeks cijena je viši za 10.5% u području Proizvodnje i snabdijevanja/opskrbe električnom energijom, plinom/gasom, parom i klimatizacijom, u području Snabdijevanja vodom; uklanjanja otpadnih voda, upravljanja otpadom te djelatnosti sanacije okoliša za 1.8%, u području Prerađivačke industrije za 0.6% i u području Vađenja ruda i kamena za 0.1%.

Posmatrano po oblastima, najveći rast indeksa cijena je registrovan/registriran u oblasti Proizvodnje koksa i rafiniranih naftnih proizvoda za 15.8%, u oblasti Proizvodnje i snabdijevanja/opskrbe električnom energijom, plinom/gasom, parom i klimatizacijom za 10.5% i u oblasti Proizvodnje kože i srodnih proizvoda za 5.3%.

U ostalim oblastima indeksi cijena se nisu značajnije mijenjali.

Ukupan indeks cijena proizvoda ča industrijskih proizvoda u novembru/studenom 2016. godine je niži za 2.7% u odnosu na isti mjesec prethodne godine, a u odnosu na decembar/prosinac 2015. godine je niži za 1.7%.

#### Indeks cijena proizvoda ča industrijskih proizvoda na domaćem tržištu

U novembru/studenom 2016. godine indeks cijena proizvoda ča industrijskih proizvoda na domaćem tržištu je viši za 1.9% u odnosu na prethodni mjesec, u odnosu na isti mjesec prethodne godine je niži za 2.2%, a u odnosu na decembar/prosinac 2015. godine je niži za 1.6%.

U ovom mjesecu najveći rast indeksa cijena registrovan/registriran je u oblasti Proizvodnje i snabdijevanja/opskrbe električnom energijom, plinom/gasom, parom i klimatizacijom za 10.8% i u oblasti Proizvodnje električne opreme za 3.4%. Najveći pad indeksa cijena registrovan/registriran je u oblasti Proizvodnje baznih metala za 4.8%.

U ostalim oblastima indeksi cijena se nisu značajnije mijenjali.

#### Producer price index-total

In November 2016 total PPI is 1.8% higher in relation to the previous month.

According to the main industrial groupings, the price index of Energy is 8.3% higher and Non-durable consumer goods is 0.3% higher. The price index in grouping Intermediate goods except energy is 0.7% lower and in Capital goods is 0.5% lower.

In grouping Durable consumer goods the price index was not changed.

According to the sections of CEA, the price index in the section of Electricity, gas, steam and air conditioning supply is 10.5% higher, in the section of Water supply; sewerage, waste management and remediation activities is 1.8% higher, in the section of Manufacturing is 0.6% higher and in the section of Mining and quarrying is 0.1% higher.

According to the divisions of CEA, the highest increase of index is registered in Manufacture of coke and refined petroleum products by 15.8%, in Electricity, gas, steam and air conditioning supply by 10.5% and in Manufacture of leather and related products by 5.3%.

In other divisions the price indices were not significantly changed.

Total PPI in November 2016 is 2.7% lower in relation to the same month of the previous year and in the relation to December 2015 is 1.7% lower.

#### Producer price index on domestic market

In November 2016 PPI on domestic market is 1.9% higher in relation to the previous month, in relation to the same month of the previous year is 2.2% lower and 1.6% lower in relation to December 2015.

In this month the highest increase of index is registered in Electricity, gas, steam and air conditioning supply by 10.8% and in Manufacture of electrical equipment by 3.4%. The highest decrease of index is registered in Manufacture of basic metals by 4.8%.

In other divisions the price indices were not significantly changed.

## **Indeks cijena proizvođača industrijskih proizvoda na inostranom /inozemnom tržištu**

U novembru/studenom 2016. godine indeks cijena proizvođača industrijskih proizvoda na inostranom/inozemnom tržištu je viši za 1.7% u odnosu na prethodni mjesec, u odnosu na isti mjesec prethodne godine je niži za 3.3%, a u odnosu na decembar/prosinac 2015. godine je niži za 1.8%.

U ovom mjesecu najveći rast indeksa cijena je registrovan/registriran u oblasti Proizvodnje koksa i rafiniranih naftnih proizvoda za 16.2%, u oblasti Proizvodnje kože i srodnih proizvoda za 5.6% i u oblasti Proizvodnje i snabdijevanja/opskrbe električnom energijom, plinom/gasom, parom i klimatizaciji za 4.1%. Najveći pad indeksa cijena registrovan/registriran je u oblasti Proizvodnje hemikalija/kemikalija i hemijskih/kemijskih proizvoda za 3.2%.

U ostalim oblastima indeksi cijena se nisu značajnije mijenjali.

## **Producer price index on non-domestic market**

*In November 2016 PPI on non-domestic market is 1.7% higher in relation to the previous month, in relation to the same month of the previous year is 3.3% lower and 1.8% lower in relation to December 2015.*

*In this month the highest increase of index is registered in Manufacture of coke and refined petroleum products by 16.2%, in Manufacture of leather and related products by 5.6% and in Electricity, gas, steam and air conditioning supply by 4.1%. The highest decrease of index is registered in Manufacture of chemicals and chemical products by 3.2%.*

*In other divisions the price indices were not significantly changed.*



## METODOLOŠKA OBJAŠNJENJA

Indeksi cijena proizvođača industrijskih proizvoda u Federaciji Bosne i Hercegovine su izračunati u skladu sa Klasifikacijom djelatnosti BiH 2010 (Službeni glasnik BiH br. 47/10) i Nomenklaturom industrijskih proizvoda BiH 2010 (Službeni glasnik BiH br. 12/11 i 41/11).

Indeks cijena proizvođača industrijskih proizvoda se izračunava na bazi prodaje proizvoda proizvedenih u Federaciji BiH, a prodatih na teritoriji Bosne i Hercegovine (domaće tržište) i izvezenih na inostrano tržište.

### Definicije

**Prodajna cijena proizvođača industrijskih proizvoda na domaćem tržištu** je cijena po kojoj proizvođač prodaje svoje proizvode kupcima na domaćem tržištu u najvećim količinama utovareno u vagon (kamion) u mjestu proizvođača, ili je cijena po kojoj proizvođač vrši obračun sa drugim proizvođačima ili trgovinskim preduzećima/poduzećima. U ovu cijenu ulazi regres koji ostvaruje proizvođač, a od cijene se odbija trgovački rabat i popusti koje prodavac odobrava kupcu. PDV i akcize se ne uključuju u cijenu.

**Prodajna cijena proizvođača industrijskih proizvoda na inostranom tržištu** je cijena po kojoj proizvođač prodaje svoje proizvode kupcima na inostranom tržištu u najvećim količinama isporučeno prema ugovorenim paritetima (EXW, FCA, FAS, FOB, CFR, CIF, CPT, CIP, DAF, DES, DEQ, DDU, DDP i dr.). U prodajnu cijenu ulazi regres koji ostvaruje proizvođač, a isključuju se rabat i popusti koje prodavac odobri kupcu. PDV i akcize se ne uključuju u cijenu.

**Indeks cijena proizvođača industrijskih proizvoda** predstavlja mjeru promjena cijena proizvoda koje industrijska preduzeća/poduzeća proizvode i prodaju na domaćem i inostranom tržištu. Ukupan indeks cijena proizvođača industrijskih proizvoda sadrži dva podindeksa, tj. indeks cijena proizvođača industrijskih proizvoda na domaćem tržištu i indeks cijena proizvođača industrijskih proizvoda na inostranom tržištu. Praćenje prodajnih cijena na ta dva tržišta daje promjene u indeksu cijena proizvođača industrijskih proizvoda ukupne industrije, glavnih industrijskih grupacija, područja i oblasti industrije.

### Namjena

Indeks cijena proizvođača industrijskih proizvoda se može koristiti kao mjeru inflacije, za očuvanje vrijednosti kod ugovora s indeksnim klausulama, te kao osnov za deflacioniranje pojedinih makroekonomskih agregata u statistici nacionalnih računa i u druge svrhe.

### Obuhvat indeksa

Indeks cijena proizvođača industrijskih proizvoda u Federaciji Bosne i Hercegovine izračunava se na osnovu prikupljenih cijena za proizvode koji se prodaju na domaćem i inostranom tržištu.

**Obuhvat proizvoda** - Obuhvaćeni su najvažniji proizvodi i usluge koje se proizvode u Federaciji BiH i prodaju na domaćem i inostranom tržištu.

Svakog mjeseca se od izabranih preduzeća prikuplja 1728 pojedinačnih cijena za izabранe proizvode.

**Obuhvat preduzeća** - Cijene se prikupljaju od 460 proizvodnih subjekata.

### Prikupljanje cijena

Za indeks cijena proizvođača industrijskih proizvoda na domaćem i inostranom tržištu cijene se prikupljaju od industrijskih preduzeća/poduzeća, mjesečno putem obrazaca C-41/DOM i C-41/INO.

### Ponderi

Ponderi za izračunavanje ukupnog indeksa cijena proizvođača industrijskih proizvoda predstavljaju relativno učešće vrijednosti prodaje pojedinih proizvoda i na domaćem i na inostranom tržištu.

## NOTES ON METHODOLOGY

The Producer price indeces in Federation of Bosnia and Herzegovina are calculated according to the Classification of activities BiH 2010 (Službeni glasnik BiH br. 47/10) and Nomenclature of Industrial Products BiH 2010 (Službeni glasnik BiH br. 12/11 i 41/11).

The Producer price index is calculated based on production value of industrial products produced in Federation of BiH and sold on the territory of Bosnia and Herzegovina (domestic market) and exported on non-domestic market.

### Definitions

**Industrial producer price on domestic market** is either price at which a producer sells products at the domestic market in the largest quantities, franco loaded into a wagon (truck) at the location of a producer or a price charged to another company by a producer. The selling price includes reimbursements if applicable, and it excludes commercial rabbates, discounts, VAT and excises.

**Industrial producer price on non-domestic market** is price at which producer sells products at the non-domestic market in the largest quantities delivered according to the agreed parities (EXW, FCA, FAS, FOB, CFR, CIF, CPT, CIP, DAF, DES, DEQ, DDU, DDP and etc.). The selling price includes reimbursements if applicable, and it excludes commercial rabbates, discounts, VAT and excises.

**Producer Price index** represents the measurement of price change of industrial products produced and sold by enterprises on domestic and non-domestic market.

Total PPI is composed of two subindices, i.e. the industrial producer price index on the domestic market and industrial producer price index on the non-domestic market. Monitoring of selling prices for these two markets provides changes in PPI for total industry, the main industrial groupings, sections and divisions of industry.

### Purpose

The PPI can be used as a measure of inflation, to preserve the value of contracts with escalator clauses, as well as a base for deflating macroeconomic aggregates in statistics of national accounts and for other purposes.

### Index coverage

Producer Price index in Federation of BiH is calculated based on collected prices for products sold on domestic and non-domestic market.

**Product coverage** - All relevant products and services produced by enterprises located in the Federation of BiH and sold on domestic and non-domestic market are covered by this index.

Each month 1728 single prices are collected from selected enterprises.

**Enterprises coverage** - The prices are collected from 460 producers.

### Price collection

For Producer Price Indices of industrial products on the domestic and non-domestic market, all items the prices are being collected once a month through C-41/DOM and C-41/INO forms.

### Weights

Weights used for calculating the total PPI represent the relative share of value of sale for each products on domestic and non-domestic market.

Ponderi koji se primjenjuju za izračunavanje indeksa cijena proizvođača industrijskih proizvoda na domaćem tržištu su koeficijenti koji odražavaju relativno učešće vrijednosti prodaje pojedinog proizvoda u ukupnoj vrijednosti prodaje svih proizvoda na domaćem tržištu.

Ponderi koji se primjenjuju za izračunavanje indeksa cijena proizvođača industrijskih proizvoda na inostranom tržištu su koeficijenti koji odražavaju relativno učešće vrijednosti prodaje pojedinog proizvoda u ukupnoj vrijednosti prodaje svih proizvoda na inostranom tržištu.

Osnovni izvor podataka za izradu pondera je Godišnji izvještaj industrije (IND-21).

Za izradu ponderacionog sistema koji je primjenjen pri izračunu indeksa cijena proizvođača industrijskih proizvoda korišteni su podaci za 2010. godinu (bazna godina).

Nova ponderacija se radi svake pete godine, dok se korekcija pondera vrši svake godine. Kao korektivni faktor se koriste indeksi kretanja cijena proizvoda u toj godini.

#### Klasifikacija i nomenklatura

Za obračun indeksa cijena proizvođača industrijskih proizvoda upotrebljava se Klasifikacija djelatnosti (KD BiH 2010) prema kojoj se poslovni subjekti razvrstavaju u područja B,C,D i E i Nomenklatura industrijskih proizvoda (NIP BiH 2010).

#### Agregiranje

Izračunavanje indeksa cijena proizvođača industrijskih proizvoda počinje izračunavanjem mjesecnih indeksa prostom geometrijskom sredinom za pojedine proizvode koje proizvodi više proizvođača. Agregirani indeksi se nakon toga izračunavaju korištenjem Laspeyres-ove formule za ponderisanu aritmetičku sredinu počevši od indeksa pojedinih proizvoda pa do ukupnih indeksa (ukupnog, indeksa na domaćem tržištu i indeksa na inostranom tržištu), za Federaciju Bosne i Hercegovine.

Weights used for calculating the PPI on the domestic market reflect the relative importance value of sale for each product in the total value production sold on the domestic market.

Weights used for calculating the PPI on the non-domestic market reflect the relative importance value of sale for each product in the total value production sold on the non-domestic market.

The main source of data for calculating weights is the Annual Survey on Industrial Production (IND-21).

For the production of weighting system applied for calculation of PPI, data for 2010 (based year) were used.

The new ponderation has been done each five years, while correction of weights has been done each year. Indices of price movements of products in that year are used as correction factor.

#### Classification and nomenclature

For calculating the price index, the PPI Classification of Activities (CEA B&H 2010) is used by which legal entities are classified in sections B, C, D and E and Nomenclature of Industrial Products (NIP B&H 2010).

#### Aggregation

Producer Price Index calculation starts from the computation of monthly average indices for each product produced by more than one producer, using simple geometric mean. Aggregated indices are calculated by using Laspeyres formula for weighted arithmetic mean starting from the level of representative products to the all indices (total PPI, PPI on domestic market and PPI on non-domestic market) at the level of Federation Bosnia and Herzegovina.
