KLANJE STOKE I PERADI U KLAONICAMA U FEDERACIJI BIH MAJ/SVIBANJ 2017.

LIVESTOCK AND POULTRY SLAUGHTERED IN ABATTOIRS IN THE FEDERATION OF BiH
MAY 2017

U maju/svibnju 2017. godine, u odnosu na maj/svibanj 2016. godine, u ukupnim kategorijama stoke smanjen je broj zaklanih goveda za 32,8%, a neto težina za 34,3%. Broj zaklanih ovaca povećan je za 14,0%, a neto težina za 20,5%. Broj zaklanih svinja smanjen je za 16,6%, a neto težina za 19,7%.

Broj zaklane peradi povećan je za 1,1%, a neto težina za 4,7% u odnosu na maj/svibanj 2016.godine.

Concerning the total livestock categories, in May 2017 compared to May 2016, there was a decrease of 32.8% in the number of slaughtered cattle and by 34.3% in their net weight. The number of slaughtered sheep increased by 14.0% and by 20.5% in their net weight. The number of slaughtered pigs decreased by 16.6% and by 19.7% in their net weight.

Concerning the slaughtered poultry there was an increase of 1.1% in the number and by 4.7% in their net weight, compared to May 2016.

METODOLOŠKA OBJAŠNJENJA

Podaci o broju grla zaklane stoke i peradi po vrstama i kategorijama, bruto težini (težini žive stoke i peradi), neto težini (težini zaklane stoke i peradi) i podaci o randmanima prikupljaju se mjesecnim izvještajem o klanju stoke i peradi u klaonicama za pravna lica (PO-52) i za obrnike (PO-52a).

Izvještajne jedinice za istraživanje PO-52 su pravne osobe i dijelovi pravnih osoba razvrstani prema KD BiH 2010 za obavljanje djelatnosti 10.11-Prerada i konzerviranje mesa i 10.12-Prerada i konzerviranje mesa peradi.

Izvještajne jedinice za istraživanje PO-52a su veterinarske stanice i kantonalne uprave za inspekcijske poslove za obrnike registrovane prema KD BiH 2010 za obavljanje djelatnosti 10.11-Prerada i konzerviranje mesa i 10.12-Prerada i konzerviranje mesa peradi.

Definicije

Bruto težina predstavlja težinu stoke i peradi prije klanja izraženu u tonama.

Neto težina je težina očišćenog trupa zaklane stoke i peradi bez kože, krvi, glave (osim kod odojaka i peradi), utroba, prednjih nogu do koljena i stražnjih nogu do skočnog zglobova, izraženo u tonama.

Randman zaklane stoke i peradi predstavlja odnos težine zaklane stoke i peradi (neto težine) i težine žive stoke i peradi (bruto težine), a iskazuje se u postocima sa jednom decimalom.

Pokazatelji ovog istraživanja koriste se za izračunavanje proizvodnje mesa u registrovanim klaonicama i za izračunavanje ekonomskih računa u poljoprivredi.

NOTES ON METHODOLOGY

Data on the number of slaughtered livestock and poultry by types and categories, gross and net weight of livestock and poultry, as well as the coefficient of utilization are collected by monthly report on slaughtering of livestock and poultry in slaughterhouses for legal entities (PO-52) and for entrepreneurs (PO-52a) collects.

Reporting units for survey PO-52 are legal entities and parts of legal entities classified, according to the KD B&H 2010 in class 10.11-Processing and preserving of meat and class 10.12-Procesing and preserving of poultry meat.

Reporting units for survey PO-52a are veterinary services and cantonal veterinary inspections for entrepreneurs registered according to the KD B&H 2010 in class 10.11-Processing and preserving of meat and class 10.12 -Procesing and preserving of poultry meat.

Definitions

Gross weight is the weight of livestock and poultry in tons and before slaughter.

Net weight is the weight of dressed carcass of slaughtered livestock and poultry without skin, blood, head (except piglets and poultry), womb, front legs to the knee and the back legs to the hock, in tons.

Coefficient of utilization is ratio of weight of slaughtered cattle and poultry (net weight) and the weight of livestock and poultry (gross weight), and is expressed as a percentage with one decimal.

These indicators are used to review the calculation of domestic production in registered slaughterhouses, and calculation of economic accounts in agriculture.
