

**KLANJE STOKE I PERADI U KLAONICAMA U FEDERACIJI BIH  
AUGUST/KOLOVOZ 2017.**  
*LIVESTOCK AND POULTRY SLAUGHTERED IN ABATTOIRS IN THE FEDERATION OF BIH  
AUGUST 2017*

U augustu/kolovozu 2017. godine, u odnosu na august/kolovoz 2016. godine, u ukupnim kategorijama stoke smanjen je broj zaklanih goveda za 8,5%, a povećana neto težina za 7,6%. Broj zaklanih ovaca povećan je za 51,6%, a neto težina za 71,2%. Broj zaklanih svinja povećan je za 23,3%, a neto težina za 17,3%.

Broj zaklane peradi povećan je za 5,1%, a smanjena neto težina za 0,2% u odnosu na august/kolovoz 2016.godine.

*Concerning the total livestock categories, in August 2017 compared to August 2016, there was a decrease by 8.5% in the number of slaughtered cattle and increased by 7.6% in their net weight. The number of slaughtered sheep increased by 51.6% and by 71.2% in their net weight. The number of slaughtered pigs increased by 23.3% and by 17.3% in their net weight.*

*Concerning the slaughtered poultry there was an increase by 5.1% in the number and decreased by 0.2% in their net weight, compared to August 2016.*

## METODOLOŠKA OBJAŠNJENJA

Podaci o broju grla zaklane stoke i peradi po vrstama i kategorijama, bruto težini (težini žive stoke i peradi), neto težini (težini zaklane stoke i peradi) i podaci o randmanima prikupljaju se mjesečnim izvještajem o klanju stoke i peradi u klaonicama za pravna lica (PO-52) i za obrtnike (PO-52a).

Izveštajne jedinice za istraživanje PO-52 su pravne osobe i dijelovi pravnih osoba razvrstani prema KD BiH 2010 za obavljanje djelatnosti 10.11-Prerada i konzerviranje mesa i 10.12-Prerada i konzerviranje mesa peradi.

Izveštajne jedinice za istraživanje PO-52a su veterinarske stanice i kantonalne uprave za inspekcijske poslove za obrtnike registrovane prema KD BiH 2010 za obavljanje djelatnosti 10.11-Prerada i konzerviranje mesa i 10.12-Prerada i konzerviranje mesa peradi.

### Definicije

**Bruto težina** predstavlja težinu stoke i peradi prije klanja izraženu u tonama.

**Neto težina** je težina očišćenog trupa zaklane stoke i peradi bez kože, krvi, glave (osim kod odojaka i peradi), utrobe, prednjih nogu do koljena i stražnjih nogu do skočnog zgloba, izraženo u tonama.

**Randman zaklane stoke i peradi** predstavlja odnos težine zaklane stoke i peradi (neto težine) i težine žive stoke i peradi (bruto težine), a iskazuje se u postocima sa jednom decimalom.

Pokazatelji ovog istraživanja koriste se za izračunavanje proizvodnje mesa u registrovanim klaonicama i za izračunavanje ekonomskih računa u poljoprivredi.

## NOTES ON METHODOLOGY

Data on the number of slaughtered livestock and poultry by types and categories, gross and net weight of livestock and poultry, as well as the coefficient of utilization are collected by monthly report on slaughtering of livestock and poultry in slaughterhouses for legal entities (PO-52) and for entrepreneurs (PO-52a) collects.

Reporting units for survey PO-52 are legal entities and parts of legal entities classified, according to the KD B&H 2010 in class 10.11-Processing and preserving of meat and class 10.12-Processing and preserving of poultry meat.

Reporting units for survey PO-52a are veterinary services and cantonal veterinary inspections for entrepreneurs registered according to the KD B&H 2010 in class 10.11-Processing and preserving of meat and class 10.12-Processing and preserving of poultry meat.

### Definitions

**Gross weight** is the weight of livestock and poultry in tons and before slaughter.

**Net weight** is the weight of dressed carcass of slaughtered livestock and poultry without skin, blood, head (except piglets and poultry), womb, front legs to the knee and the back legs to the hock, in tons.

**Coefficient of utilization** is ratio of weight of slaughtered cattle and poultry (net weight) and the weight of livestock and poultry (gross weight), and is expressed as a percentage with one decimal.

These indicators are used to review the calculation of domestic production in registered slaughterhouses, and calculation of economic accounts in agriculture.
