PROMET NA AERODROMIMA / U ZRAČNIM LUKAMA, II tromjesečje 2020.
TRAFFIC IN AIRPORTS, 2nd quarter 2020

Promet aviona/zrakoplova u aerodromskim/zračnim lukama u periodu IV-VI 2020. godine u odnosu na isti period 2019. godine manji je za 85,8%.

Aircraft traffic at airport in period April - June 2020 decreased by 85.8% in relation to same period of last year.

Promet putnika u aerodromskim/zračnim lukama u periodu IV-VI 2020. godine u odnosu na isti period 2019. godine manji je za 94,8%.

Passengers turnover at airport in period April - June 2020 decreased by 94.8% in relation to same period of last year.

Promet tereta u aerodromskim/zračnim lukama u periodu IV-VI 2020. godine u odnosu na isti period 2019. godine manji je za 44,4%.

Freight turnover at airport in period April - June 2020 decreased by 44.4% in relation to same period of last year.

METODOLOŠKA OBJAŠNJENJA

Izvori i metode prikupljanja podataka

Podaci o aerodromskim uslugama dobiveni su iz istraživanja Tromjesečni izvještaj o aerodromskim uslugama (obrazac SA-AER/T).

Jedinice posmatranja

Jedinice posmatranja koje pružaju aerodromske usluge su poslovni subjekti registrirani prema KD BiH 2010 (NACE Rev. 2). u području H, u razredu 52.23 - Uslužne djelatnosti u vezi sa zračnim prijevozom. Podaci aerodroma/zračnih luka odnose se samo na usluge komercijalnih letova.

Definicije

Promet aviona/zrakoplova na aerodromima/u zračnim lukama obuhvata broj operacija slijetanja i polijetanja na posmatranim aerodromima/zračnim lukama domaćih i stranih aviona/zrakoplova.

Odnosi se samo na usluge komercijalnih letova.

Pod pojmom prijevoz podrazumijeva se kretanje putnika ili tereta od jednog mjesta (mjesto ukrcaja/utovara) do drugog mjesta (mjesto iskrcaja/istovara) i predstavlja rad transportnih preduzeća/poduzeća.

Promet putnika na aerodromima/ zračnim lukama obuhvata broj putnika prispjelih na posmatrane aerodrome/zračne luke i otpremljene domaćim i stranim avionima/zrakoplovima. Obuhvaćeni su putnici i teret čija zračna putovanja počinju ili završavaju na aerodromu/ zračnoj luci koja izvještava. Isključeni su putnici u tranzitu.

Međunarodni prijevoz obuhvata prijevoz putnika između mjesta ukrcaja u našoj zemlji i mjesta iskrcaja u inozemstvu i obrnuto.

NOTES OF METHODOLOGY

Source and methods of data collection

Data on transport at airports are collected by using the reporting method through the Quarterly Report on Transport in Airports (SA-AER/T).

Reporting units

Reporting units in transport at airports are business entities that are registered in the Section H of CA BiH 2010 (NACE Rev. 2) in the class 52.23 - Service activities incidental to air transportation. Data on airports refer only to commercial air transport services.

Definitions

Aircraft traffic in airports includes number of operations of landing and taking-off of domestic and foreign aircraft in observed airports.

It refers only on services of commercial flights.

Considered as transport is movement of passenger or cargo from one place (loading place) to another place (unloading place) and representing the operation of transport enterprises.

Traffic of passengers in airports includes number of passengers' arrivals and departures by domestic and foreign aircraft in observed airports. It includes passengers and freight whose air journey begins or finishes at the reporting airport. Passengers in transit are excluded.

International transport is conveying of passengers between the place of embarkment in our country and the place of disembarkment abroad, or the other way round.
