

**KLANJE STOKE I PERADI U KLAONICAMA  
AVGUST/KOLOVOZ 2024.  
LIVESTOCK AND POULTRY SLAUGHTERED IN ABATTOIRS  
AUGUST 2024**

U avgustu/kolovozu 2024. godine, u odnosu na avgust/kolovoz 2023. godine u ukupnim kategorijama stoke broj zaklanih goveda veći je za 14,0%, dok je neto težina ukupno zaklanih goveda veća za 19,3%.

Ukupan broj zaklanih ovaca manji je za 40,3%, svinja za 1,5%, peradi za 6,5%, dok je neto težina ukupno zaklanih ovaca manja za 40,4%, peradi za 7,5%, a veća neto težina ukupno zaklanih svinja za 1,2%.

Concerning the total livestock categories, in August 2024 compared to August 2023 in total number of slaughtered livestock was recorded increase of 14.0% for cattle, while net weight of slaughtered cattle increased by 19.3%.

Decrease was recorded in number of slaughtered sheep by 40.3%, pigs by 1.5% and poultry by 6.5%, while net weight of slaughtered sheep decreased by 40.4%, poultry by 7.5% and increase was recorded in net weight of slaughtered pigs by 1.2%.

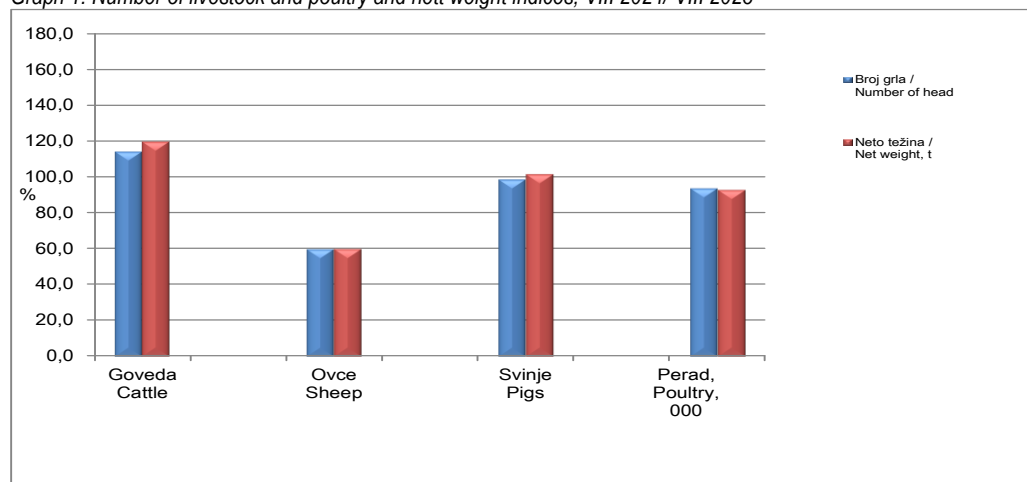

## KLANJE STOKE I PERADI U KLAONICAMA

### Obuhvat i izvještajne jedinice:

Podaci o klanju stoke i peradi u klaonicama prikupljaju se redovnim mjesečnim istraživanjem za poslovne subjekte, posebno za pravne osobe i dijelovi pravnih osoba (PO-52), a posebno za obrtnike (PO-52a).

Istraživanje se provodi na osnovu/temelju Zakona o statistici u Federaciji BiH („Sl. Novine FBiH“ br. 63/03 i 9/09).

Opširnija metodološka objašnjenja za ovo istraživanje objavljena su u „Službenim novinama FBiH“ br. 102/17 i na internet stranici Federalnog zavoda za statistiku

### Obuhvat

Prikupljaju se podaci o broju grla zaklane stoke i peradi po vrstama i kategorijama, bruto težini, neto težini i randmanu. Iskazuje se sva zaklana stoka i perad bez obzira na porijeklo.

Jedinice posmatranja i jedinice izvještavanja, za istraživanje PO-52 su pravne osobe i dijelovi pravnih osoba razvrstani prema KD BiH 2010 za obavljanje djelatnosti 10.1-Prerada i konzerviranje mesa i 10.12-Prerada i konzerviranje mesa peradi.

Izvještajne jedinice za istraživanje PO-52a su veterinarske stanice i kantonalne uprave za inspeksijske poslove za obrtnike registrovane prema KD BiH 2010 za obavljanje djelatnosti 10.11-Prerada i konzerviranje mesa i 10.12-Prerada i konzerviranje mesa peradi.

### Definicije

**Bruto težina** predstavlja težinu stoke i peradi prije klanja izraženu u tonama.

**Neto težina** je težina očišćenog trupa zaklane stoke i peradi bez kože, krvi, glave (osim kod odojaka i peradi), utrobe, prednjih nogu do koljena i stražnjih nogu do skočnog zgloba, izraženo u tonama.

**Randman zaklane stoke i peradi** predstavlja odnos težine zaklane stoke i peradi (neto težine) i težine žive stoke i peradi (bruto težine), a iskazuje se u postocima sa jednom decimalom.

Pokazatelji ovog istraživanja koriste se za izračunavanje proizvodnje mesa u registrovanim klaonicama i za izračunavanje ekonomskih računa u poljoprivredi.

## LIVESTOCK AND POULTRY SLAUGHTERED IN ABATTOIRS

### Covering and report units:

The data on slaughtered of livestock and poultry in slaughterhouses are collected through the regular monthly surveys for business entities, separately for legal entities and part of legal entities (PO-52), and separately for entrepreneurs (PO-52a).

This survey is conducted on the bases of Law on Statistical Survey in Federation of B&H ("Official Gazette FB&H" No. 63/03 and 9/09).

More detailed notes on the Methodology of this survey are published in "Official Gazette FB&H" No. 102/17 and on the web site of the Institute for Statistics of FBiH

### Coverage

The data on the number of slaughtered cattle and poultry by types and categories, gross weight, net weight and randman are collected. All slaughtered cattle have been presented be regardless of their origin.

Observation and reporting units for survey PO-52 are legal entities and parts of legal entities classified, according to the KD B&H 2010 in class 10.11-Processing and preserving of meat and class 10.12-Processing and preserving of poultry meat.

Reporting units for survey PO-52a are veterinary services and cantonal veterinary inspections for entrepreneurs registered according to the KD B&H 2010 in class 10.11-Processing and preserving of meat and class 10.12 -Processing and preserving of poultry meat.

### Definitions

**Gross weight** is the weight of livestock and poultry in tons and before slaughter.

**Net weight** is the weight of dressed carcass of slaughtered livestock and poultry without skin, blood, head (except piglets and poultry), womb, front legs to the knee and the back legs to the hock, in tons.

**Coefficient of utilization** is ratio of weight of slaughtered cattle and poultry (net weight) and the weight of livestock and poultry (gross weight), and is expressed as a percentage with one decimal.

These indicators are used to review the calculation of domestic production in registered slaughterhouses, and calculation of economic accounts in agriculture.
