KLANJE STOKE I PERADI U KLAONICAMA, JANUAR/SIJEČANJ 2015. LIVESTOCK AND POULTRY SLAUGHTERED IN ABATTOIRS, JANUARY 2015

U januaru 2015. godine, u odnosu na januar prethodne godine, u ukupnim kategorijama stoke bilježi se smanjenje kod klanja goveda u broju za 6,0% i neto težini za 7,5% te kod klanja ovaca u broju za 51,5% i neto težini za 49,5%.

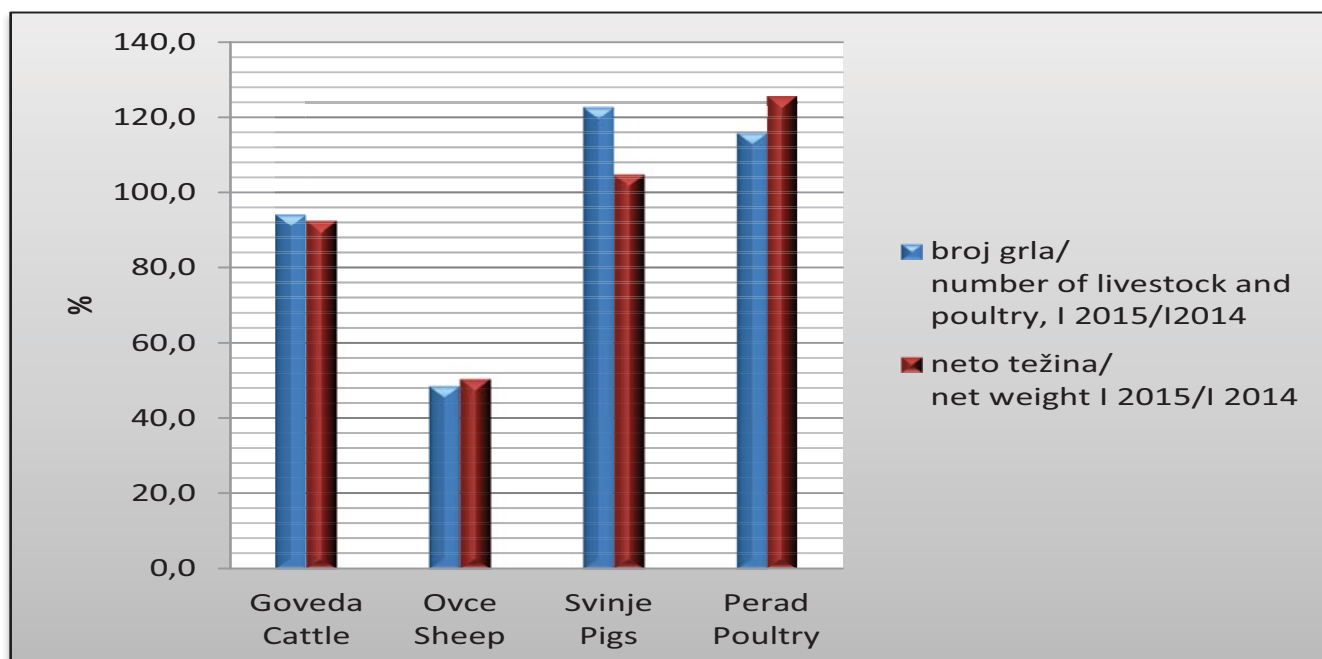
Kod klanja svinja i peradi u januaru 2015, u poređenju sa januarom 2014. godine, bilježi se povećanje, i to kod svinja povećanje u broju za 22,7% i neto težini za 4,9%, te kod peradi povećanje u broju za 15,9% i neto težini za 25,5%.

Concerning the total livestock categories, in January 2015 as compared to January of the previous year, there was the decrease of 6.0% in the number and of 7.5% in the net weight of the slaughtered cattle as well as of 51.5% in the number and of 49.5% in the net weight of the slaughtered sheep.

Concerning the slaughtered pigs and poultry, in January 2015 as compared to January 2014, there was the increase of 22.7% in the number and of 4.9% in the net weight of the slaughtered pigs as well as of 15.9% in the number and of 25.5% in the net weight of the slaughtered poultry.

Metodološka objašnjenja

Podaci o broju grla zaklane stoke i peradi po vrstama i kategorijama, bruto težini (težini žive stoke i peradi), neto težini (težini zaklane stoke i peradi) i podaci o randmanima prikupljaju se mjesečnim izvještajem o klanju stoke i peradi u klaonicama za pravna lica (PO-52) i za obrtnike (PO-52a)

Izveštajne jedinice za istraživanje PO-52 su pravne osobe i dijelovi pravnih osoba razvrstani prema KD BiH 2010 u djelatnost prerada i konzerviranja mesa (Područje C-Prerađivačka industrija, Oblast 10, Grana 10.1, Razred 10.11-Prerada i konzerviranje mesa i 10.12-Prerada i konzerviranje mesa peradi).

Izveštajne jedinice za istraživanje PO-52a su veterinarske stanice i kantonalne uprave za inspeksijske poslove za obrtnike registrovane prema KD BiH 2010 za obavljanje djelatnosti prerade i konzerviranja mesa (Područje C-Prerađivačka industrija, Oblast 10, Grana 10.1, Razred 10.11-Prerada i konzerviranje mesa i 10.12-Prerada i konzerviranje mesa peradi).

Bruto težina predstavlja težinu stoke i peradi prije klanja izraženu u tonama.

Neto težina je težina očišćenog trupa zaklane stoke i peradi bez kože, krvi, glave (osim kod odojaka i peradi), utrobe, prednjih nogu do koljena i stražnjih nogu do skočnog zgloba, izraženo u tonama.

Randman zaklane stoke i peradi predstavlja odnos težine zaklane stoke i peradi (neto težine) i težine žive stoke i peradi (bruto težine), a iskazuje se u postocima sa jednom decimalom.

Pokazatelji ovog istraživanja koriste se za izračunavanje proizvodnje mesa u registrovanim klaonicama i za izračunavanje ekonomskih računa u poljoprivredi.

Notes on methodology

Data on the number of slaughtered livestock and poultry by types and categories, gross and net weight of livestock and poultry, as well as the coefficient of utilization are collected by monthly report on slaughtering of livestock and poultry in slaughterhouses for legal entities (PO-52) and for entrepreneurs (PO-52a) collects.

Reporting units for survey PO-52 are legal entities and parts of legal entities classified, by Classification of economic of B&H 2010, activity processing and preserving of meat (Area C Manufacturing, Section 10, Group 10.1, Class 10.11-Processing and preserving of meat and Class 10.12-Processing and preserving of poultry meat).

Reporting units for survey PO-52a are veterinary services and cantonal veterinary inspections for entrepreneurs registered, by Classification of economic of B&H 2010, for activity of processing and preserving of meat (Area C Manufacturing, Section 10, Group 10.1, Class 10.11-Processing and preserving of meat and Class 10.12 - Processing and preserving of poultry meat).

Gross weight is the weight of livestock and poultry in tons and before slaughter.

Net weight is the weight of dressed carcass of slaughtered livestock and poultry without skin, blood, head (except piglets and poultry), womb, front legs to the knee and the back legs to the hock, in tons.

Coefficient of utilization is ratio of weight of slaughtered cattle and poultry (net weight) and the weight of livestock and poultry (gross weight), and is expressed as a percentage with one decimal.

These indicators are used to review the calculation of domestic production in registered slaughterhouses, and calculation of economic accounts in agriculture.
