BILANS NAFTNIH DERIVATA, 2014. BALANCE OF OIL DERIVATS, 2014

Ukupan uvoz naftnih derivata u FBiH u 2014. godini iznosio je 701.867 t.

Total imports of oil derivats in the FB&H in 2014 was 701.867 t.

Ukupna količina naftnih derivata raspoloživa za potrošnju u FBiH u 2014. godini iznosila je 697.125 t.

The total amount of oil products available for consumption in FBiH in 2014 was 697.125 t.

U ukupnoj potrošnji derivata nafte potrošnja u energetsom sektoru iznosi 30.236 tona.

In total consumption of petroleum products, the consumption in the energy sector is 30.236 tons.

U ukupnoj finalnoj potrošnji, koja u 2014. godini iznosi 660.332 tone naftnih derivata najveći udio ima saobraćaj 90,7%, građevinarstvo 6,0%, industrija 2,9%, dok domaćinstva, poljoprivreda i ostali potrošači zajedno imaju učešće 0,4%.

In total final energy consumption of 660.332 tons of petroleum products in 2014, the largest share has transport sector of 90,7%, construction with 6,0%, industry 2,9%, while households, agriculture and other sectors participate with 0,4%.

METODOLOŠKA OBJAŠNENJA

Podaci o Bilansu naftnih derivata dobijaju se na osnovu rezultata godišnjih statističkih istraživanja iz oblasti energetike i to: Godišnjeg izvještaja o trgovini naftnim proizvodima (EN-NT-G), Godišnjeg izvještaja o proizvodnji i potrošnji toplotne energije (EN-T1-G), Godišnjeg izvještaja o utrošku energenata u industriji (EN-IND-G), kao i podataka dobivenih iz statistike vanjske trgovine.

Izveštajne jedinice o utrošku i distribuciji naftnih proizvoda su preduzeća/poduzeća, koja su po Klasifikaciji djelatnosti razvrstana u Registru poslovnih subjekata u području C - Prerađivačka industrija i D - Proizvodnja i snabdijevanje/opskrba električnom energijom i plinom (35.4) i G - Trgovina na veliko i na malo; popravak motornih vozila i motocikala (46.71 i 47.30).

Metodologija za izradu bilansa naftnih derivata usklađeni su sa standardima IEA/OECD i Eurostat-a.

Godišnjim izvještajem o trgovini naftnim derivatima prikupljaju se podaci o trgovini i potrošnji naftnih derivata u različitim oblastima.

NOTES ON METHODOLOGY

Data on activities energy are collected by the Institute for Statistics of FB&H through the Annual report of trade of oil dervats (EN-NT-G), Annual report of production and consumption heat (EN--T1-G) and Annual report on energy consumption in industry (EN-IND-G), as well as data from external trade statistics.

Reporting units on the production and distribution of oil products are enterprises classified according to the Classification of Activitis in the Register of Business Entities in section C - Manufacturing industry, D - Production and supply of electricity and gas (35.4) and G - Wholesale and retail trade; repair of motor vehicles and motorcycles (46.71 i 47.30).

Methodology for balance of Oil Derivats is harmonized with standards IEA/OECD and Eurostat.

Annual survey on oil derivates collect data about oil trade and consumption oil derivates in different section.
